- Kieth: RCC plays an important role communicating to the SCC
- Jim: I am an Amtrak host – volunteer drivers are picking up folks from the Amtrak station
- Candy: I have been looking to update taxi services in the region. If anybody knows of a taxi services that people are using please let me know.
- P&L
  - Kieth: NH has to raise just \$2200/month to provide the cash match to run the volunteer driver program.
  - Jim: I try to communicate with City Council about the importance of supporting warrant article on the ballot. The council needs to hear from people that use the services. These services are so critical.
  - Barbara: Are we worried about 70% of 5310 funding be expended for salaries but we are only 50% through the fiscal year?
    - Kieth: We try to pull local match. We are always worried, but the agency keeps going. We find match.
- Need to discuss in April the need for new members. Go by the RCC bylaws. Reach out if interested in serving as officer.

### **Statewide Updates:**

Teri Palmer has taken the ED position at Advance Transit.

Fred: NH DOT is working with DHHS to see if State Mobility manager could be funded through their department. Currently funded as a short-term position through Rural Health Transformation grant as a stop-gap. Looking for long-term home. Hopefully in the next month we will have a concrete path forward for funding.

### **Member and Partner Updates**

Jacopo: Point 32 Health Foundation has a grant. Would like to extend this into Sullivan County. Partner with local senior centers. Working with Cornish Elementary on May 6 Walk/Bike to School Day. Working with Bike Walk Alliance of NH.

Fred: Federal DOT reviewing equitable distribution of funds. We don't necessarily have metrics for measuring/documenting what is equitable. Trying to use this survey to understand how we are using federal funds. For 5310 RCC funds we are looking at seniors and people with disabilities.

Candy: We will compile feedback from members and submit this at the next meeting.
