3. SFY 2022 FTA Section 5310 Capital Grant Application update

4. Mobility Manager Report

C. Yanski submitted the Rides Report for MST, VDP and TVP. There was a general discussion about the data. Cindy continued that MCDOC asked if individuals going through mental health court could also use the program. After reviewing the contract it was determined an amendment is not needed, just the approval of this council. Trips for approved applicants will begin in September. E. Drury asked if veterans court could also use the TVP.

5. New Intercity Concord\Laconia CAT Route

C. Yanski asked T. Paige if she would talk about the proposed intercity CAT route. Still in the rough mapping phase, T. Paige anticipates a deviated, fixed-route with potentially 6 runs a day (round trip) running along Route 3 through downtown Penacook, with stops at the new Exit 17 shopping center, VA cemetery, the County Complex in Boscawen, the industrial park in Franklin, through downtown Franklin, Market Basket and Walmart in Tilton, the Belknap Mall, into downtown Laconia. There was some general discussion about the plans.
